Meeting Content

*Committee Chair, Monica Kruse, read a statement recognizing the long stewardship provided La Crosse County by the Ho Chunk Nation, underscoring the stake the Nation continues to have in land use policy.

* Charlie Handy gave an overview of the Existing Conditions Report. He noted that about half a dozen chapters are 50%-85% complete, the majority at 95%. To attain 100%, public input will be solicited on every chapter.

* In an Introduction to Farmland Preservation Charlie Handy listed multiple stakeholders in the farm community who are being surveyed about farmland preservation. Surveys will be completed during in-person workshops or online.

* Committee members divided into three small groups (rural, urban, urban-rural). They reviewed lists of features that describe their particular region of La Crosse County. They brainstormed: 1. balancing town/municipalities autonomy vs redundant infrastructure and multijurisdictional plan and policies; 2. achieving sustainable, collaborative & respectful boundary agreements that guide future land uses; 3) identifying data and information needed to create such policy.
